ASSOCIATE MEMBERS

- Any entity or individual, that derives 50 percent or more of its total sales volume from the field of business in aviation or any entity not qualified for corporate membership and which does not own or operate aircraft of any kind, but an entity having a pervasive interest in business aviation, is eligible for an Associate membership subject to approval by the Governing Body through unanimous resolution.

SPONSOR MEMBERS

Sponsor membership is open to large entities such as Aircraft manufacturers, Finance companies and others with a significant interest in the sector.
